Mission Triangle Member Agreement

From time to time, the Lord brings people and organizations together in order to achieve a common goal. With capacity limitations which we all face we want to give your nonprofit the opportunity to consider both the benefits and expectations of a formal partnership agreement with Mission Triangle. Simply stated, Mission Triangle wants to invest our time and resources effectively in the nonprofits who are committed to joining us on the journey toward health and sustainability.

At this time, we invite your nonprofit to become a Nonprofit Member with Mission Triangle for a two-year partnership with your organization (not an individual). While this is a non-binding agreement, we are excited to work further with nonprofits willing make this deeper level of commitment.

Mission Triangle Member Criteria:

- Your nonprofit (senior staff / board member) must have attended at least 2 Mission Triangle quarterly workshops in the past 18 months and have at least 3 individuals complete the corresponding assessments. *If your nonprofit goes 6 months without attending the workshops, you will be inactive as a “Nonprofit Member” until you then attend two quarterly workshops and corresponding assessments.*
- Nonprofit has a general operating budget of \$100,000+ for the past (completed) fiscal year.
- Operate, to the best of your ability, in a healthy manner as defined by MT assessments.
- Leadership (board/senior staff) agrees with the Mission Triangle Statement of Faith.
- Your organization is a 501©3 recognized organization in good standing with the state of NC.

What Mission Triangle agrees to do:

- **Coaching:** prioritization in supporting your work through quarterly coaching, offering at least one 90-minute coaching session per quarter
- **Consulting:** preference for fee-based consulting services
- **Resources:** access to workshop resources via our website that are not available to the general public
- **Counsel:** feedback on materials you are creating to execute on principles or tools taught
- **Platform:** list your nonprofit on the Mission Triangle website as a Nonprofit Member which will be public for the giving community and others to see – demonstrating that your nonprofit is doing the hard work
- **Special Opportunities:** consider your nonprofit in granting and Shark Tank level opportunities. Only Nonprofit Members will be considered for these opportunities.

What your nonprofit agrees to do:

- **Engage:** participate fully in programs such as quarterly workshops, small groups, and 1:1 coaching sessions. Nonprofit members will also respond to requests for workshop and small group surveys.
- **Assess:** complete the Mission Triangle Baseline Health Assessment annually and all quarterly Mission Triangle core competency assessments. In order to track Mission Triangle impact, we must track your growth.
- **Grow:** complete and share with Mission Triangle the nonprofit growth plan that will be part of each workshop, simply capturing the priorities your nonprofit identifies following the assessment and training.
- **Update:** maintain a current “Ministry Profile” with Mission Triangle
- **Champion:** encourage other nonprofits to consider participating with Mission Triangle

We certainly understand that extenuating circumstances arise that may make meeting these expectations impossible or difficult and we simply ask that you make us aware of the challenge in a timely manner so we can balance accountability with grace – as we ONLY want your organization to maximize its Kingdom impact!
